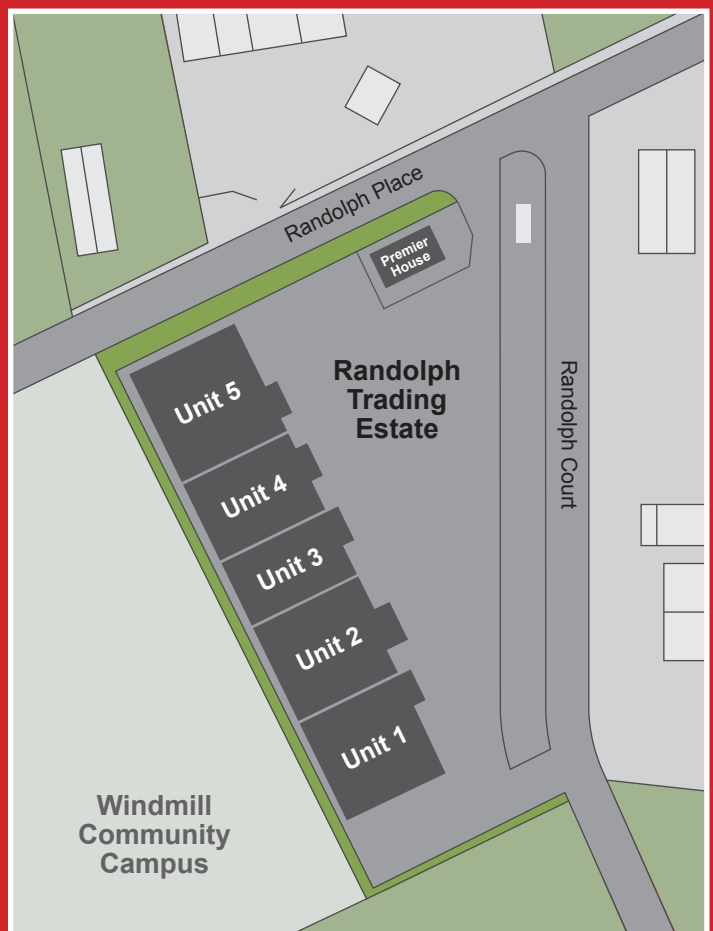
### Overview

The estate is undergoing refurbishment to make it more attractive to trade counter operators.

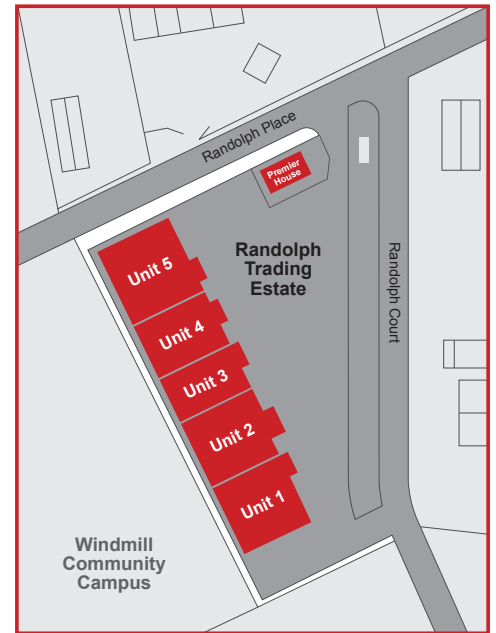

## Directions

From the A92/ A921 roundabout, take the A921/ Rosslyn Street turn-off for Kirkcaldy, then continue across the next roundabout on the A921.

At the next roundabout turn left into Windmill Road, and then second left onto Randolph Place.

Randolph Trading Estate is located a few hundred metres on the right hand side.

## Costs/Lease Terms

**Rent** - Upon application.

**Service Charge** - The estate has a service charge for the upkeep and maintenance of the common areas which each tenant contributes to - including the landlord on vacant units.

**Rates** - Each tenant/occupier pays the rates on their own property.

**EPCs** - Each individual unit will have its own EPC, copies of which are available upon request.
